

The Corporation of the Town of South Bruce Peninsula

By-Law Number 55-2021

**Being a By-Law to Regulate Activities on the
Sand Beach Known as Sauble Beach in the
Town of South Bruce Peninsula**

Whereas the Municipal Act, 2001 S.O. 2001 c.25 s.9 provides that Section 8 and 11 of the Municipal Act, 2001 shall be interpreted broadly so as to confirm broad authority on the Town to enable it to govern its affairs as the Council considers appropriate, and to have the Town's ability to respond to Municipal issues.

And whereas the Council deems it desirable to pass a by-law for the prohibition or regulation of the activities that are carried out on the sand beach known as Sauble Beach in the Town of South Bruce Peninsula.

Now therefore the Council of the Corporation of the Town of South Bruce Peninsula enacts as follows:

1. Short Title

This by-law may be also known as the "Sauble Beach By-Law"

2. Applicability

This by-law applies to those lands described in Schedule "A" attached hereto and forming part of this by-law.

3. Definitions

For the purpose of this by-law the following definitions apply:

3.1 "Animal"

Means any member of the animal kingdom, other than a human, without limiting the generality of the foregoing, including dogs, cats, birds, cows, horses, pony, mule, donkey, jackass, goat, sheep and cow.

3.2 "Beach"

As referred to in this by-law shall mean those lands described in Schedule "A".

3.3 "By-Law Enforcement Officer/Provincial Offences Officer"

Means person appointed to enforce the by-laws of the Town.

3.4 "Camp or Camping"

Means the use and occupation of a tent or other shelter, hut or temporary dwelling whether or not the use includes sleeping or eating.

3.5 "Clerk"

Means the Clerk of the Corporation of the Town of South Bruce Peninsula.

3.6 "Cooking Device"

Means any barbeque, hot plate, oven or other device used for the cooking, preparing, heating or warming of food, drink or any other item.

3.7 "Council"

Means the Council of the Corporation of the Town of South Bruce Peninsula.

3.8 "Littering"

Means any placing or disposing of any dirt, paper, cups, handbill, household waste, oil, gas, wood, brush, refuse, feces, broken items, chairs, clothing or any item not meant to be placed, located or left on the Beach.

3.9 "Motor Vehicle"

Means any motorized vehicle, any motor driven cycle, motorcycle or snowmobile as defined in the **Motor Vehicle Act**, and any off-road vehicle as defined in the **Off-Road Vehicle Act**, and includes any scooter, e-bike, golf cart or other device driven by battery or electrical power, and includes any trailer or accessory attached to the motor vehicle, but does not include devices used by a person with a disability (ie. motorized wheelchair).

3.10 "Service Animal"

As defined in the Accessibility for Ontarians with Disabilities Act, 2005 as may be amended from time to time, a service animal is an animal for a person with a disability if it is readily apparent that the animal is used by the person for reasons relating to his or her disability or if the person provides a letter from a physician or nurse confirming that the persons requires the animal for reasons relating to the disability.

3.11 "Tent"

Means any portable shelter that you are unable to see through, or has four sides, but does not include a sun canopy or kitchen tent that does not contain sides.

3.12 "Town"

Means the Corporation of the Town of South Bruce Peninsula.

4. General Provisions

4.1 No person(s) shall have, park, operate or drive a motor vehicle on the beach as described in Schedule A of this by-law.

- 4.2 No person(s) shall use a generator or other such devices that are powered by gas, diesel, propane, or any other fuel on the Beach.
- 4.3 No person(s) shall permit, allow, have or carry a dog from June 1st to Labour Day in each and every year on the Beach.
- 4.4 No person(s) shall camp overnight on the Beach.
- 4.5 No person(s) shall erect, have or occupy a tent on the Beach.
- 4.6 No person(s) shall cut, damage or remove dune grass or plants or trees from the Beach.
- 4.7 No person(s) shall have or use any device for the purpose of cooking while on the Beach.
- 4.8 No person(s) shall set, have or use a fire of any kind on the Beach.
- 4.9 No person(s) shall deposit litter on the Beach other than in garbage barrels provided for such litter.
- 4.10 No person(s) shall build a solid structure made of any material on the Beach.
- 4.11 No person(s) shall offer for sale any item on the Beach.
- 4.12 Notwithstanding Subsection 4.3 above, no person(s) shall permit or cause an animal to be on the Beach.
- 4.13 No person(s) shall have or consume any beverage containing alcohol on the Beach.

5. **General Exemptions**



- 5.1 This by-law does not apply to:
- a. All service animals while performing or training for their duties. Example: seeing eye, hearing impaired, police and any other animal that is certified for a job and is engaged in performing or training for their duties.
 - b. Any activities or function approved by the Town of South Bruce Peninsula.
 - c. By-Law Department employees while performing their duties.
 - d. All police officers while performing their duties.
 - e. All medical rescue personnel while performing their duties.

- f. All employees and designates of the Town of South Bruce while performing their duties.



6. Penalty

- 6.1 No person(s) shall interfere with an officer while performing their duty pursuant to this by-law.
- 6.2 Every person(s) who violates a provision of this by-law is guilty of an offence and upon conviction is liable to the penalty as provided in Section 61 of the Provincial Offences Act R.S.O 1990 Chapter 33 as amended from time to time.
7. That By-Law 102-2017 will be repealed and replaced with this by-law upon approval of set fines associated with this by-law.

Property:

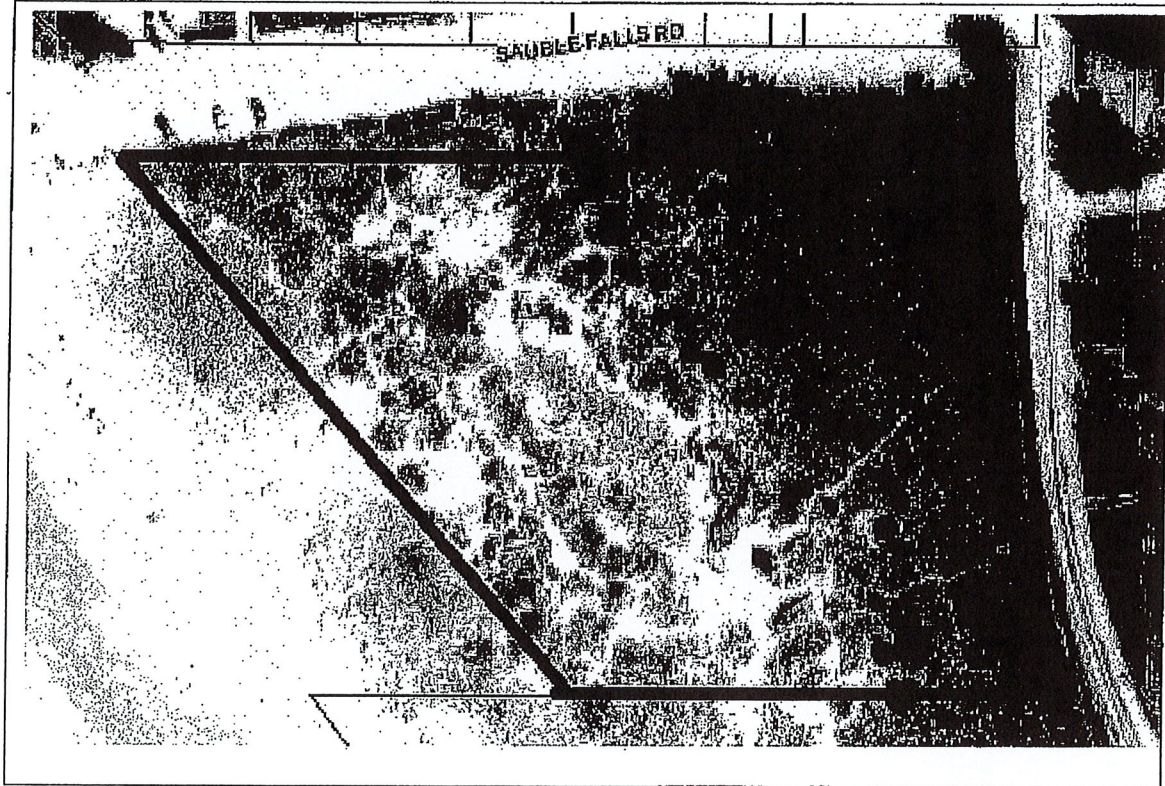

- 2 That is west of Lakeshore Blvd. being the property Tax Roll 41-02-540-011-16500-0000 and being Concession D Part Lot 26.
- 3 That is west of Lakeshore Blvd. North being the property Tax Roll 41-02-540-011-16300-0000 and Concession D Part Lot 26.
- 4 That is west of Lakeshore Blvd North being the property Tax Roll 41-02-540-011-16301-0000 and being Concession D Part Lot 26.
- 5 That is west of Lakeshore Blvd. North being the property Tax Roll 41-02-540-011-16200-0000 and being Concession D Part Lot 26.
- 6 That is west of Lakeshore Blvd. North being the property Tax Roll 41-02-540-013-21201-0000 Plan 378 Lot A Accretion W of Lot 30 Concession D.

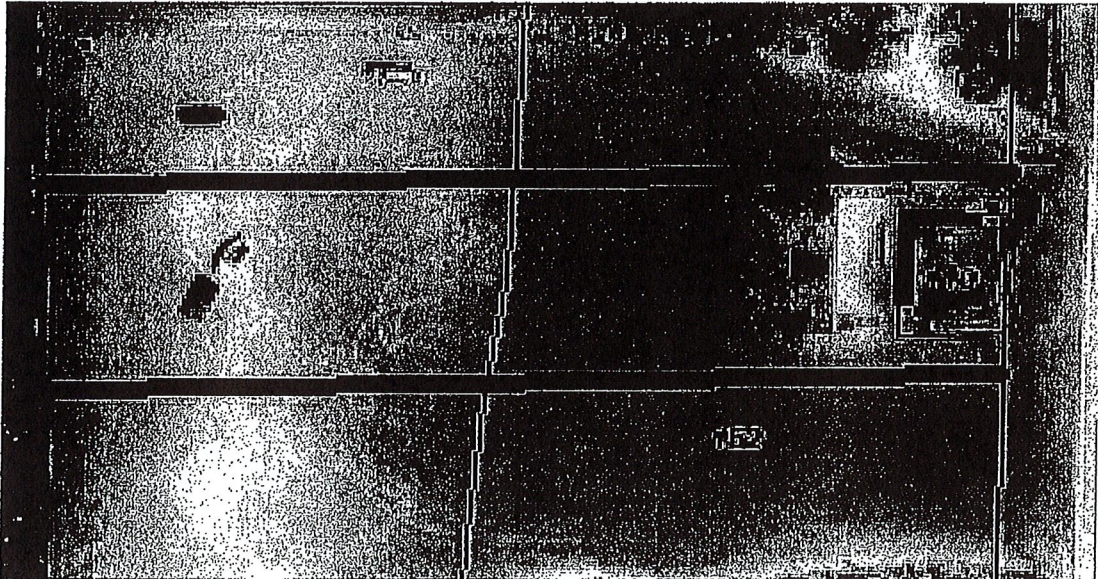

1. Short Title

2. This by-law applies to those lands described in **Schedule "A"** attached hereto and forming part of this by-law.

3. Definitions

For the purpose of this by-law the following definitions apply:

3.1 "Animal"

Means any member of the animal kingdom, other than a human, without limiting the generality of the foregoing, including dogs, cats, birds, cows, horses, pony, mule, donkey, jackass, goat, sheep and cow on any land described in Schedule A.

3.2 "Beach"

As referred to in this by-law shall mean those lands described in Schedule A which are not covered by water.

3.3 "By-Law Enforcement Officer/Provincial Offences Officer"

Means person appointed to enforce the By-laws of the Town.

3.4 "Clerk"

Means the Clerk of the Corporation of the Town of South Bruce Peninsula.

- 3.5 “Council”**
Means the Council of the Corporation of the Town of South Bruce Peninsula.
- 3.6 “Camp or Camping”**
Meaning a temporary shelter such as a tent, hut or other temporary dwellings.
- 3.7 “Littering”**
Means any placing or disposing of any dirt, paper, cups, handbill, household waste oil or gas, or any refuse.
- 3.8 “Motor Vehicle”**
Means any motorized vehicle, any motor driven cycle, motorcycle or snowmobile as defined in the **Motor Vehicle Act** or an Off road vehicle as defined in the **Off-Road Vehicle Act** and includes any trailer or accessory attached to the motor vehicle, but does not include bicycles, wheelchairs or motorized wheelchairs.
- 3.9 “Service Animal”**
As defined in the Accessibility for Ontarians With Disabilities Act, 2005 as may be amended from time to time, a service animal is an animal for a person with a disability if it is readily apparent that the animal is used by the person for reasons relating to his or her disability or if the person provides a letter from a physician or nurse confirming that the persons requires the animal for reasons relating to the disability.
- 3.10 “Tent”**
Means any portable shelter, dwelling that you are unable to see through, but does not include a sun canopy or kitchen tent that does not contain sides.
- 3.11 “Town”**
Means the Corporation of the Town of South Bruce Peninsula.

4. General Provisions

- 4.1** No person(s) shall drive a motor vehicle on the beach as described in Schedule A of this by-law.
- 4.2** No person(s) shall use a generator or other such devices that are powered by gas, diesel, propane, or any other fuel on the beach as described in Schedule A of this by-law.
- 4.3** No person(s) shall permit, allow or carry a dog from June 1st to Labour Day in each and every year on the beach as described in Schedule A of this by-law.

- 4.4 No person(s) shall camp overnight on the beach as described in Schedule A of this by-law.
- 4.5 No person(s) shall erect a tent on the beach as described in Schedule A of this by-law,
- 4.6 No person(s) shall cut damage or remove dune grass or plants or trees from the beach as described in Schedule A of this by-law.
- 4.7 No person(s) shall use any device for the purpose of cooking while on the beach as described in Schedule A of this by-law.
- 4.8 No person(s) shall set fire of any kind on the beach as described in Schedule A of this by-law.
- 4.9 No person(s) shall deposit litter on the beach as described in Schedule A of this by-law other than in garbage barrels provided for such litter.
- 4.10 No person(s) shall build a solid structure made of any material on the beach as described in Schedule A of this by-law.
- 4.11 No person(s) shall offer for sale any item on the beach as described in Schedule A of the by-law.
- 4.12 Notwithstanding Subsection 4.3 above, no person(s) shall permit or cause an animal to be on the beach as described in Schedule A of this by-law.



5. **General Exemptions**

- 5.1 This by-law does not apply to:
 - a. All service animals while performing or training for their duties. Example: seeing eye, hearing impaired, police and any other animal that is certified for a job and is engaged in performing or training for their duties.
 - b. Any activities or function approved by the Town of South Bruce Peninsula.
 - c. By-Law Department employees while performing their duties.
 - d. All police officers while performing their duties.
 - e. All medical rescue personnel while performing their duties.
 - f. All employees and designates of the Town of South Bruce while performing their duties.



6. Penalty

7. That any by-law or a portion thereof that is inconsistent with this by-law is hereby repealed.
8. That this by-law shall take effect upon the passing thereof.

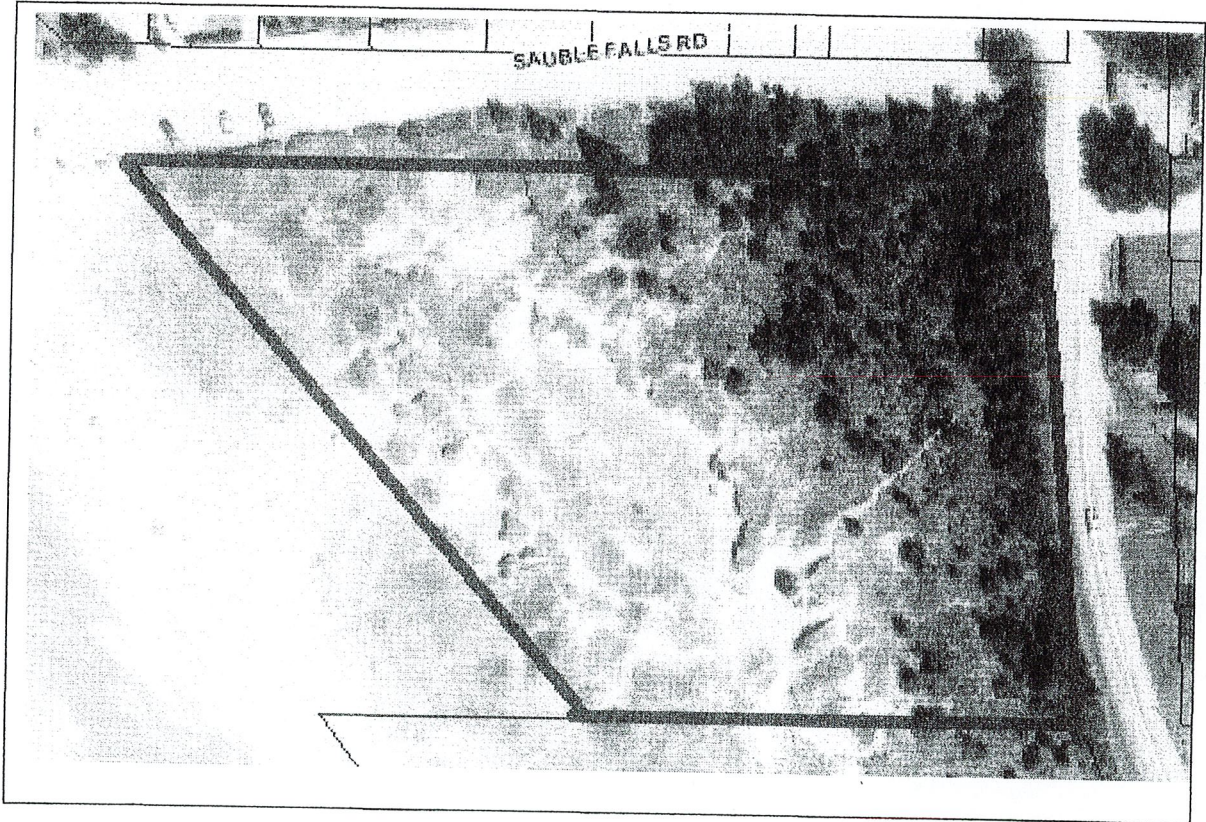

- 5 That is west of Lakeshore Blvd. North being the property Tax Roll 41-02-540-011-16200-0000 and being Concession D Part Lot 26.
