Berford Street Reconstruction and Streetscaping Improvement Project George Street to Division Street

What happened this week?

The Contractor, Bridge Excavating Ltd., has been busy flushing the sewer lines and conducting Closed-circuit TV video inspection of the storm and sanitary sewers to locate the connections from the mains to the buildings.

Utility locates have been ordered and completed; perhaps you've noticed all the colours lines on the pavement!

Bridge has also been preparing and installing additional water main valves on the side streets to facilitate the provision of temporary water services. Temporary water will be supplied to all properties within the construction zone as needed to ensure disruption to services is minimized.

Installation of fencing has also been completed to create separation between the pedestrain corridors and the worksite and to allow access to the businesses/buidings

What is happening next week?

Bridge will be completing a pre-condition survey of buildings within the affected area to ensure that the pre-construction condition is documented for everyone's protection in the event of a damage claim. It is recommended that if requested, you provide access to the interior of the building for this purpose.

Dye testing of storm and sanitary services for all structures within 50 m of the construction limits will be carried out as needed if further confirmation is required after the video inspections are completed.

Buildings between Division and William will be connected to the temporary water supply. The Public will notice 50mm diameter blue pipes along the pedestrian fencing, and some buildings will have lines connected to outside taps being fed from other buildings.

Major construction activity will begin at the intersection of Division and Berford Street for storm and sanitary sewer works.

Road Closures:

Berford Street is expected to be closed to vehicle traffic between William Street and Jenny Street starting June 30.

The Beer Store will be accessible from the north end of Wiarton only, as Division street will have limited access at times. Please use the detours provided and access Berford Street from Jenny Street/County Road 13.

Customer access to the businesses will be provided via side streets, rear parking lots and pedestrian access. If you require special accommodation, please contact the Business Owner or the Contractor's Public Relations Officer for current accessibility conditions.

Should you be a business owner and require accommodation for deliveries, please contact the Contractor's Public Relations Officer.

Access for emergency vehicles will be maintained at all times.
