- 9. The contractor, applicant, owner or any agent thereof is responsible for arranging and ensuring completion of all locates (including but not being limited to gas, hydro, phone, sewer, water, cable TV, etc). No work is to begin without proper clearance from each agency. The Town assumes no liability or responsibility for clearance of utilities, lines, etc. or any damage thereto.
- 10. A mandatory deposit is required in conjunction with all road cut and sidewalk cut permit applications. The deposit must be in the form of a certified cheque made payable to the Town of South Bruce Peninsula. Said deposit will be held by the Town until the specified expiry date of this permit. At

that time, the applicant, contractor, owner or any agent thereof forfeits the deposit if it is determined by the Town that the roadway, sidewalk or any portion thereof have not been replaced or repaired to the same or better standards than prior to any commencement of works. The Town reserves the right to use all or any portion of the deposit cheque for the repair and/or replacement of the roadway, sidewalk or any portion thereof. If it is deemed by the Town that the works have been completed to a standard satisfactory to the Town, the deposit cheque will be returned to the applicant/owner.

The issue of a permit by the Town does not relieve the contractor(s), the owner(s), the applicant(s), their heirs, executors, administrators, successors and assigns from any liability and further, the contractor(s), the owner(s), the applicant(s), their heirs, executors, administrators, successors and assigns hereby agree to observe, keep, perform and be subject to the regulations and conditions of the said permit and to indemnify and save harmless the Town of South Bruce Peninsula from and against all loss, cost, charges, damages, expenses, claims and demands whatsoever for which the Town of South Bruce Peninsula may be liable by reason of anything done or omitted to be done in the construction, maintenance, alteration, or operation of the works authorized.
